MESSAGE FROM THE MANAGING TRUSTEE



The Foundation For Excellence India Trust (established in 2003), in partnership with the Foundation For Excellence (FFE), has been impacting and transforming the lives of students through higher education support. FFE's flagship Scholarship Program plays a pivotal role in providing essential financial aid to students as they navigate through their higher education endeavors, a particularly crucial assistance considering the escalating costs of education.

Dr. Prabhu Goel and Mrs. Poonam Goel laid the foundation of FFE in 1994 with a vision to catalyze transformative change in the lives of exceptionally talented students facing financial hardships. This vision was realized through scholarships and various forms of aid, supporting these students' pursuit of higher education in India.

Presently, the scope of support provided by FFE encompasses more than just financial assistance. It has evolved into a comprehensive support system, offering career-oriented skills training and mentoring that go beyond academics. This approach guides students along their educational path and equips them for the challenges of their future careers. This original vision has blossomed into a burgeoning network of students and alumni who not only excel in their professional education but also thrive in today's dynamic and demanding work landscape.

FY 2022-23 was a record year for the Foundation, with scholarships being awarded to **13,579 students** pursuing Engineering, Medicine, Law and Pharmacy degrees amounting to **Rs 59.63 crores, the highest number awarded to date.**

FFE's distinctive program, which merges financial aid with skill development (both soft skills and technical

expertise), mentoring, and avenues for internships and employment, distinguishes the FFE Scholarship.

Even students in the farthest corners of India have been able to access online learning opportunities provided by FFE, including several courses that are not part of their college curriculum. FFE expresses its gratitude to The Michael and Susan Dell Foundation (MSDF) and Capgemini for their generous grant, which has facilitated the implementation of the comprehensive training program for FFE scholars.

It was also a record year of applications received (23,000+) and awarded (4851) to first time students. 30% of scholarship awardees were women, an increase from 24% in the previous FY. FFE's efforts to engage and expand partnerships and collaborations with NGO partners and ecosystem players, along with social media outreach resulted in these significant numbers. 13% of new scholarships awardees were referrals from NGO partners. The volunteer base of Facilitators rallied hard to complete a record 6000+ virtual/in person student background verifications within a compressed window. FFE's donors continued to contribute both financially as well by engaging with students as mentors, conducting training sessions (soft skills and technical training sessions), leadership and entrepreneurship training, organizing in person office visits, offering internships and placement opportunities. The holistic program approach has resulted in high placement figures and impressive (in excess of Rs. 9 Lakh) average starting salary of the graduating class of Engineers. FFE stayed connected with its growing stakeholder community through virtual Open House events, detailed in the report, ensuring the sense of unity, camaraderie, learning and sharing experiences and challenges. .

The “Pay Forward” model, as part of FFE’s Circle of Giving has resulted in alumni donations (directly and indirectly) supporting ~ 8 % of scholarships awarded during FY 2022-23. Also, alumni have enrolled as volunteer Facilitators (to qualify students for scholarships) and mentors to FFE scholars.

The growth in the scholarship program was also made possible through 25 new donors engaging with FFE as CSR implementing partners and/or as collaborators along with several donors adding new cohorts of students to their existing sponsorship. Through these diverse interventions, FFE has effectively acted as a conduit, propelling exceptional students from challenging pasts into promising futures filled with hope and ambitious aspirations.

During this unprecedented phase of growth, FFE’s dynamic team under the leadership of Ram Kolavennu, COO - FFE India Trust has worked tirelessly to ensure the timely execution of all our initiatives.

On behalf of the Board of Trustees, we extend our heartfelt appreciation for your ongoing support as we endeavor to collaboratively work together to create lasting and significant impact.

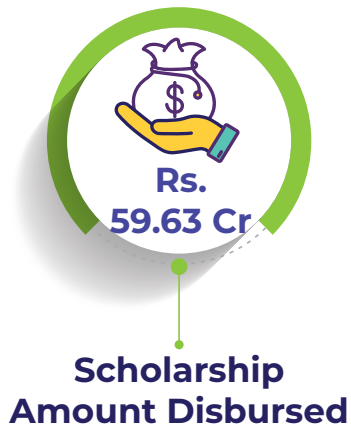

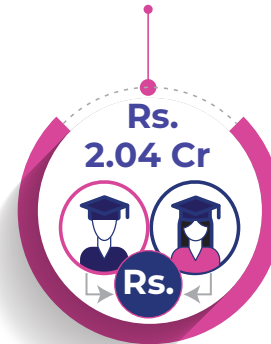

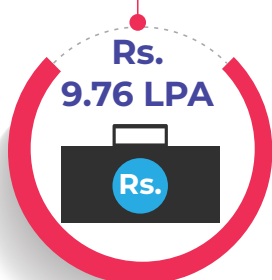

IMPACT

Dr. Prabhu Goel and Mrs. Poonam Goel, founded FFE in 1994 with the vision to bring about transformative change to the lives of brilliant students from financially disadvantaged backgrounds, pursuing higher education in India through scholarships and other assistance.

Since FFE's inception in 1994, it has helped 33,633 students in India by awarding scholarships and transforming their lives. During the past 29 years, 95,169 scholarships have been awarded to students in India, amounting to Rs. 361 crores. In FY 2022-23, a record 13,579 students throughout India were awarded scholarships amounting to Rs 59.63 crores.

FFE's comprehensive "Beyond Scholarship Program" provides holistic support to students with the goal of addressing identified skill gaps. Students in Engineering from Year 2 to 4 are exposed to in-depth training in employability and technical skills, and similarly, Law and Pharmacy students benefit from specialized training. Augmented by a Mentoring Program, these endeavors have demonstrated to be impactful interventions, fundamentally reshaping students' career trajectories and launching them into well-compensated positions and a promising future. Notably, this comprehensive support has led to higher employability rates among graduating Engineers, resulting in at least a twofold increase in income earning capacity compared to those who did not undergo such training in previous cohorts.

The influence of FFE's scholarship program reverberates through multiple generations, enabling each incoming cohort of students to envision and pursue opportunities that were once impeded by financial limitations. This all-encompassing strategy of financial and holistic support operates as a catalyst, propelling significant economic advancement for both students and their families in just one generation, thus nurturing intergenerational social and financial mobility.

He has been a donor to FFE since his graduation and has helped champion the course of FFE at Altimetrik; today there are over 50 FFE scholars whose education is being sponsored by Altimetrik.

Tharanggany was supported through FFE scholarships during her BTech from 2001-2005 at Raja College of Engineering and Technology, Madurai and has been involved with FFE since her graduation. Tharanggany, Team Manager - ERP Development works with Lennox International, Chennai, a HVAC Product Based Company. Lennox is also sponsoring the education of FFE scholars, thanks to her efforts.

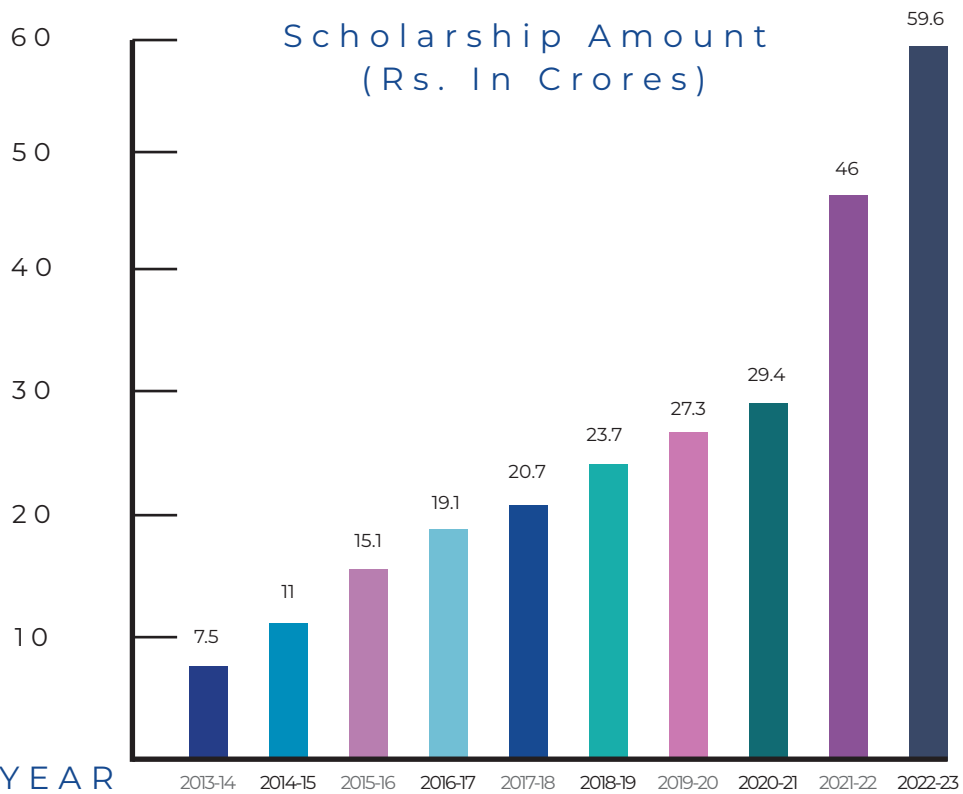
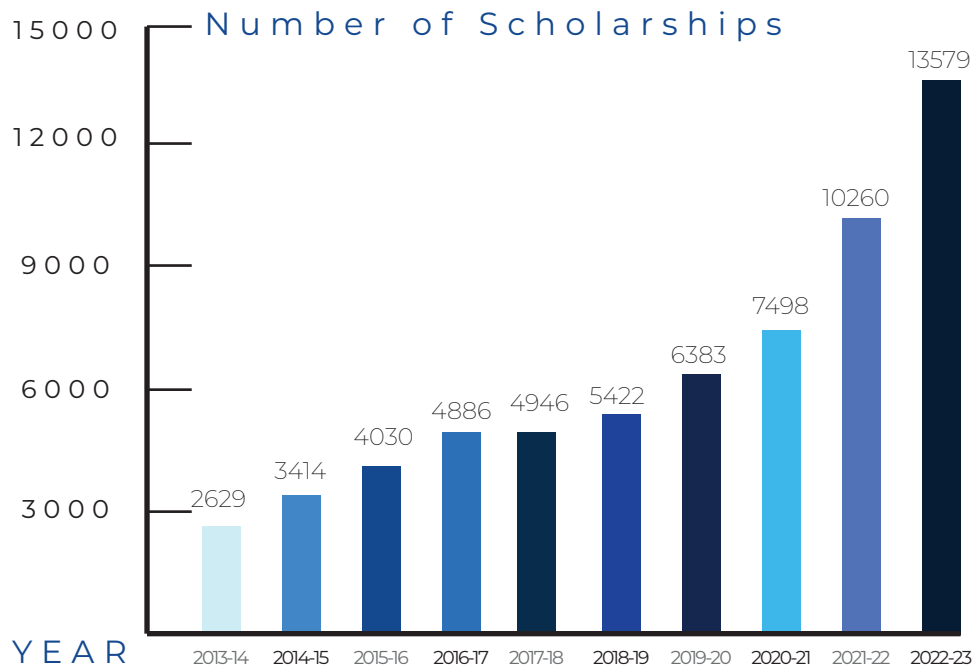

FFE'S JOURNEY IN A DECADE



PROGRAMS & ACTIVITIES IN FY 2022-23

SCHOLARSHIP PROGRAM

FFE's flagship "Scholarship Program" provides financial assistance through merit cum means scholarships that is awarded to students pursuing professional degrees in Engineering, Medicine, Pharmacy and Law.

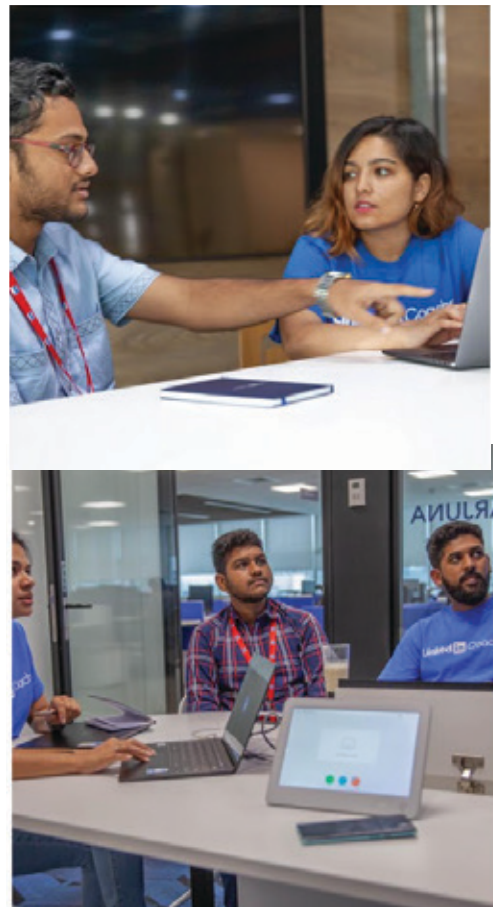
The objective of this program is to offer financial aid to exceptionally talented students hailing from economically disadvantaged backgrounds. These students might have struggled to pursue or complete their professional education due to their financial limitations. Scholarship eligibility is determined by merit and family income. All students must meet the rank criteria (based on nationalized test/ state exams) and financial criterion (annual combined family income of up to Rs. 3 Lakhs/annum). FFE does not discriminate on the basis of caste, gender, or religious affiliation. All students must meet the rank and income criteria to qualify for the scholarship.

With a successful track record spanning 29 years, FFE's Scholarship program awarded annual scholarships of minimum Rs 40,000 to eligible students during FY 2022-23. These scholarships are renewable throughout the student's academic journey until their graduation.

The support provided by the program goes beyond just financial assistance. It encompasses Student Development Programs that include skills and technical training, mentoring, opportunities for internships and employment. This comprehensive approach sets the program apart, providing students with a holistic and well-rounded experience that is both unique and effective.

In FY 2022-23, **13,579** students were awarded scholarships amounting to **Rs 59.63 crores**. This included **4851** new, first-time scholars, the highest number to date who joined the FFE family. Among the scholarships awardees during FY 2022-23, **30%** were women, representing a notable increase from the previous fiscal year's 24%. The generosity of donors worldwide undoubtedly helped expand the scholarship Program, achieving the highest numbers since inception of the Foundation.

FFE's partnership with IIT-Bombay Alumni Association, as part of its Financial Aid Program (FAP) enabled scholarships to be awarded to students at IIT-B. This included scholarships to 4 new students amounting to Rs. 3,33,500/- under the Erach & Meheroo Mehta Memorial - FFE Scholarship program.



Family Background Verification and Scholarship Application Processing



FFE is committed to identifying highly deserving students across India who meet the criteria for the merit-cum-means scholarship. The organization collaborates closely with colleges approved by AICTE to raise awareness about the scholarship program and enhance its visibility during college orientations. To date, FFE has successfully established effective communication channels with 193 colleges. This initiative, along with leveraging social media channels has yielded impressive results, with over 23,000 applications being received during FY 2022-23 as a direct outcome of these outreach efforts.

The FFE team also collaborates with India wide partner NGOs that work or assist secondary school students in preparing and successfully attempting various national and state-level entrance exams for professional education. FY 2022-23 saw FFE collaborating with 40+ NGO partners, which resulted in 750+ students being awarded FFE's scholarships through partner references and collaboration. This includes students referred by Dakshana Foundation, CSRL India, Youth Development Foundation, Dynamic Manipur, Bharat Navodaya Vigyan, Ex-Navodayan Foundation, and Avanti Fellows among others. Furthermore, information regarding the Scholarship program is disseminated among FFE's donor community, comprising individuals, corporations, and foundations. Many collaborate with and/or support schools where students, especially girls and middle school students, can aspire to pursue higher education through scholarships. FFE, through these channels, promotes the Scholarship Program.

FFE also partners closely with passionate volunteers, also known as Facilitators, who take the lead in identifying qualifying students within their own communities. FFE currently has the ongoing support of a committed cohort exceeding 600 volunteers, spanning multiple districts throughout India. During FY 2022-23, 303 volunteers played an active role in meticulously reviewing and evaluating close to 6000 applications to consider them for scholarships. Among these 303 volunteers, 185 were FFE Alumni who have volunteered their time as Facilitators. The work of these volunteers is critical to the core scholarship program, ensuring that the stringent scholarship eligibility criteria are met, thereby upholding the program's integrity.

Family income and financial need is verified by FFE through a rigorous background verification process, conducted online, (or in person where possible), that involves the student and his/her family, FFE's local volunteer and a FFE staff member. The facilitator volunteer conducts an in-depth validation of the student's information, engaging in virtual discussions with parents regarding income sources, dependents, assets, and other crucial factors that contribute to assessing the authenticity of financial need, often in the local language. Using this evaluation, the volunteer facilitator ultimately provides a conclusive recommendation regarding eligibility for FFE's scholarship.

The complete scholarship procedure is conducted online, with all documents submitted electronically.

TECHNOLOGY ENABLED INTEGRATION OF PROGRAMS



FFE's operations have shifted to become more technology enabled during the past 4-5 years. FFE's commitment to leveraging technology has paved the way for scalable and sustainable operations, transforming the organization's approach to efficiency, transparency, and collaboration. This shift has streamlined operations at multiple levels, from nurturing scholars throughout their lifecycle, managing donors, fostering alumni connections, honing employability skills, and guiding mentoring efforts and meticulously overseeing financial management – truly making it a technology-driven ecosystem.

At the core of this technological landscape lies Salesforce NPSP (Non-Profit Success Pack) – deployment of NPSP helped FFE scale, improve efficiency and bring useful insights into the operations. A significant development in FY 2022-23 was the migration of our Salesforce Org from the classic version to the lightning version. This was made possible through the dedicated efforts of domain experts from Cognizant Technologies who provided pro bono services to FFE. This was followed by a series of technology enhancements that were seamlessly executed, making the process more streamlined. Furthermore, FFE made a conscientious effort in rendering the application process more accessible through mobile devices, ensuring inclusivity and ease of access.

Skill Development and Job Readiness Program

Commencing in the fiscal year 2017-18, FFE's Employability Skill Development Program has thrived for the past six years, propelled by generous grants from the Michael and Susan Dell Foundation (MSDF). Generous grants from Capgemini during the fiscal years 2019-20 and 2022-23 have continued to support this invaluable program. The central objective of the Wrap Around Skills initiative is to equip FFE scholars with essential 21st-century skills vital for employability and their professional journeys.

This all-encompassing four-year training initiative incorporates curated skills training, delivered through partnerships with diverse vendors. The program is tailored to suit Engineering, BPharm, and Law students, spanning their first to fourth years of study. Its inception involved first-year students undergoing a diagnostic assessment named AMCAT (Aspiring Minds' Computer Adaptive Test). This assessment identifies specific skill gaps, evaluating FFE scholars in Aptitude (Logical and Quantitative), English (assessed via SVAR voice-based evaluation), and Written Communication.

During the second year of Engineering, BPharm, and Law studies, the Employability & Skilling program focused on improving the English and Aptitude skills of FFE scholars. This was executed using app-based training platforms, complemented by Pre and Post assessments. The English language training was facilitated by vendor partner, Kings Learning. Following completion of this phase (one semester), students progressed to app-based Aptitude training that was offered by either of two vendor partners: FACE (Focus Academy for Career Enhancement) or Ethnus. Performance scores from the Midline assessment directed students towards either continuing with advanced English skill development (advanced English or high-touch English) or opting for Coursera Certification courses. The latter covered advanced subject training and the latest technical reskilling demanded by the competitive job market.

For the third year Engineering students, options included Advanced Spoken English and Coursera courses. The Advanced English Program employed an online virtual communication platform delivered by eAge Tutors, concentrating on refining communication skills, corporate readiness, and interview handling prowess of the scholars.

The Coursera courses available to FFE scholars comprised specializations, offering over five certification courses in Mechanical, Electrical, Computer Science, Information Technology, and Civil Engineering within each branch/specialization. This initiative aimed to directly augment students' employability upon graduation.

An integral aspect of FFE's efforts to enhance scholars' employability was the Mock Interview Sessions. Administered by FFE's partner Ethnus, these sessions were tailored to third-year Engineering students transitioning into their fourth year. Beyond simulation, these Mock Interviews sought to pinpoint and address skill gaps, evaluate interview readiness, and enhance preparedness for job interviews in a competitive arena.

In the final year, an Endline test is administered that provides valuable feedback to students regarding their preparedness, prior to the commencement of campus interviews or placements.

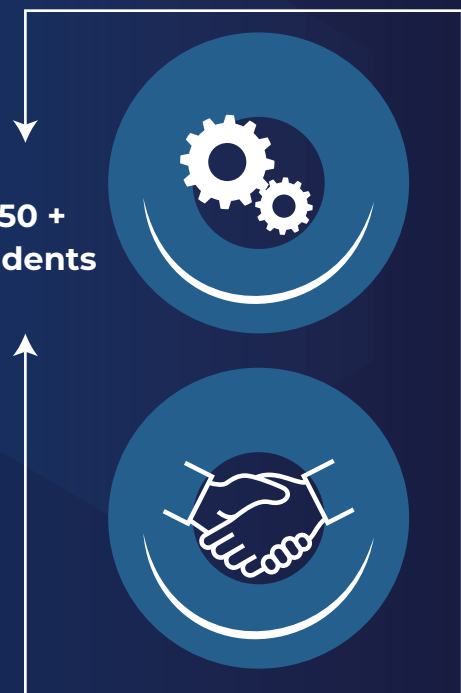


A total of 276 FFE scholars participated in these workshops, organized in 9 batches during the fiscal year 2022-23.

WORKSHOPS, WEBINARS AND TRAINING BY CORPORATE PARTNERS AND EMPLOYEE ENGAGEMENT

FFE leveraged its network of corporate donors to establish a range of learning opportunities that encompassed a variety of subjects for students. This initiative included a total of 14 technical sessions and 8 soft skill sessions, all of which were facilitated by 4 corporate partners and 1 NGO partner. These sessions were supplementary to FFE's organized skills training program. With the participation of over 450 students, these sessions enhanced the overall learning experience for the students.

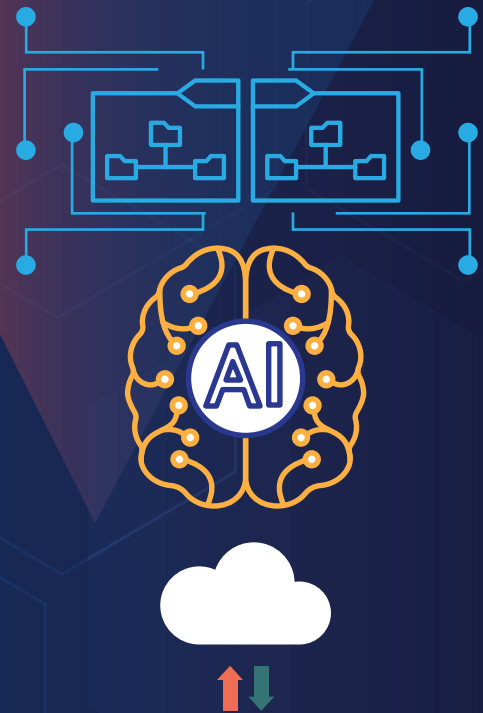


CORPORATE WORKSHOPS FOR FFE SCHOLARS AND EMPLOYEE ENGAGEMENT

IBM Skills Build Program

Starting in 2021, FFE partnered with IBM for the Skills Build program, offering technical courses targeted at IT/CS scholars. This collaboration encompasses a 6-week camp focusing on Front End Development, Data Analytics, Artificial Intelligence, and other domains that provides comprehensive training, including modules, mini-projects, portfolio discussions with mentors, and more.

In 2022, 195 IT & CS scholars in the 2nd and 3rd year, attended the Artificial Intelligence and Cybersecurity course offered through the IBM Skill Building Program.

Virtual LINKEDIN Coaches Session

A LinkedIn Coaches Session for 4th year Engineering scholars on “How to create a strong LinkedIn profile” was conducted by LinkedIn on 9th September 2022. The session, which had over 100 participants, delved into diverse aspects essential for crafting an effective LinkedIn profile.

Machine Learning Session by AMAZON

Amazon conducted a Machine Learning session on "**Driving Innovation with ML**" for all FFE Engineering scholars on 9th August 2022. This was presented by **Mr. Rajeev Rastogi**, Vice President of Machine Learning at Amazon. With over 500 participants, it was an engaging session with lively interaction between scholars and the speaker.

Communication Course

A total of 120 scholars in their second year participated in the communication course meticulously designed by Maker Bhavan Foundation and administered by CMI. Spanning a duration of 10 weeks, this course is designed to enhance communication skills. It combines both instructor-led sessions and self-paced learning modules, offering a comprehensive approach to enhancing various facets of scholars' communication abilities.

WADHWANI Job- Ready Program

A pilot course was offered to 50, fourth-year engineering scholars on employability skills. This included a weekly mentor-led session that focused on various modules pertinent to the corporate workforce and facilitated interactions with the mentor.

WADHWANI Job-ready Foundation Program

A foundational program targeted at students in the initial stages of their professional education commenced with a cohort of 50 second-year engineering scholars. The program's primary objective was to establish a strong basis for industry preparedness, while also enhancing scholars' proficiency in corporate etiquette and other essential skills needed for being job-ready.

UNACADEMY Shikshodaya Program

With program commencement on September 9, 2022, this comprehensive postgraduate coaching program, was designed to assist scholars aspiring for advanced studies in the medical and engineering disciplines. The program admitted a total of 16 FFE female scholars, supported through scholarships, who were chosen based on their success in the NAT (National Aptitude Test) held on July 30, 2022.



Amazon Future Engineer (AFE) Boot Camp

In January 2023, Amazon introduced the inaugural bootcamp for Amazon Future Engineers (FFE), for a cohort of 200 women FFE scholars. This extensive six-month initiative is focused on imparting rigorous training on Data Structures and Algorithms (DSA) using Java. The curriculum encompasses 22 modules, each tackled through weekly live sessions, mentor-led doubt clarification classes, assessments, and assignments. Exceptional performance in the program also opened doors for students to secure internships at Amazon.

In the summer of 2023, a total of 68 scholars were selected to participate in the Amazon Internship program for the following roles:

1. **Software Development Engineer**
2. **Data Engineer**
3. **Support Engineer**
4. **Quality Assurance Engineer**



The AFE camp comprised rigorous training in advanced programming skills essential for excelling in assessments and successfully navigating Amazon's internship evaluation procedures.

TiE Entrepreneurship Program

A pilot group for the Entrepreneurship program offered by TiE, commenced on March 4th 2023, consisting of 25 Engineering scholars in the 2nd and 3rd years. This 8-week course, scheduled over weekends, was divided into two phases. The initial 4 weeks were dedicated to workshops encompassing dynamic discussions, comprehensive training, and innovative idea generation. During this phase, mentoring sessions were organized, involving the formation of scholar groups and one-on-one interactions with mentors. The program culminated with a pitch night event, where the most promising entrepreneurial ideas were recognized and awarded.

Civil Service session by FFE Alumni



On 16th October 2022, a panel discussion was organised for students interested in the Civil Services and for UPSC aspirants titled, "Making dreams a reality". The panelists included 3 FFE alumni, **Ms. Sanjita Mohapatra** - Asst. Secretary GOI- New Delhi, **Mr. Sonu Bhatt** - Asst. Commissioner (UT), Faridabad and **Mr. Madhusudhan Reddy** - District Collector, Sivagangai, Tamil Nadu. The session encompassed the journey and experiences of these officials (from being FFE scholars to their current positions), motivational insights, and strategies for excelling in the Civil Services examination. The discussions covered various aspects of Civil Services, including its scope, opportunities, and prospects. The session concluded with an engaging and interactive Q&A discussion.

Pharmacy Career Guidance Session

On 3rd November 2022, a career guidance session was conducted for all BPharm scholars by **Dr. Ramgopal Rao S**, Senior Academy Manager – Biocon Academy. A total of 113 BPharm scholars participated in the session, gaining valuable insights into the essential skills required to achieve their 'dream jobs', along with an exploration of the diverse opportunities within the pharmaceutical industry.

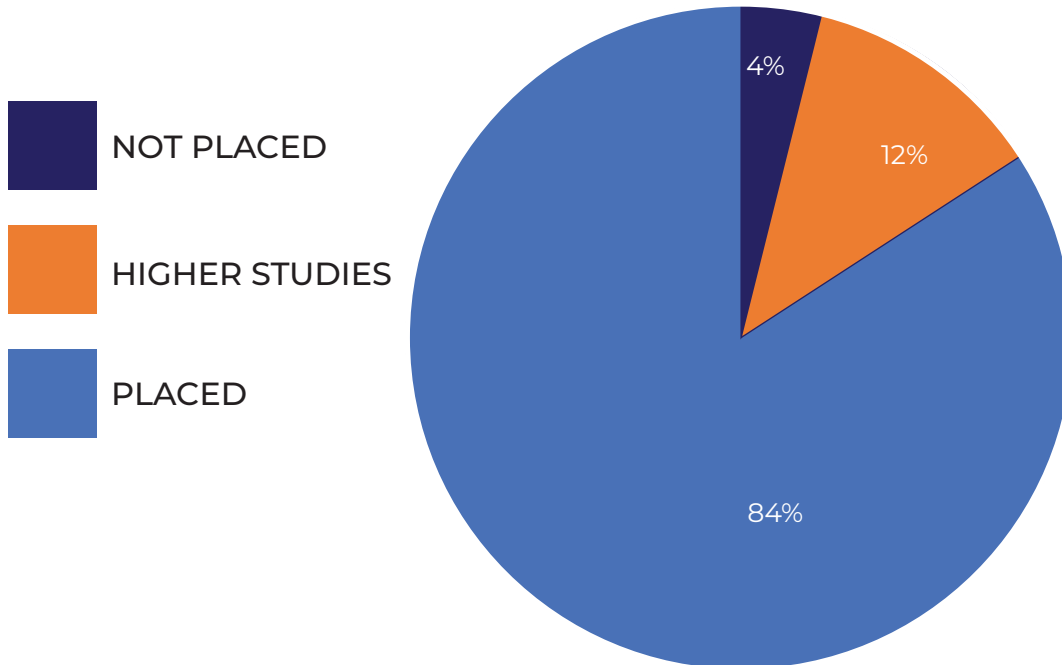
LinkedIn In Day

Of the 1256 Engineering scholars who graduated in June 2022, 1048 (84%) gained employment, and 154 (12%) were interested in pursuing their higher education. 54 (4%) scholars continued to seek employment as of 30th April 2023. The average salary of the placed students in this cohort was observed to be 9.76 Lakhs per Annum.



MENTORING

FFE's In-House Mentoring Program for Career Readiness

FFE's Mentorship program is committed to providing timely career guidance to its Mentees (primarily 3rd Year students) by facilitating interactions with industry experts, resulting in positive and impactful outcomes. FFE's 4–6 month virtual Mentoring program enables FFE scholars to receive personalized guidance from seasoned professionals across various fields (Engineers, Lawyers, Pharmacists, and more). FFE's specially curated in-house curriculum provides the framework for the mentoring sessions while mentors contribute their own valuable experiences to enrich the mentorship. The program addresses skill gaps faced by students and bridge those gaps, aiding students not only in gaining internships and employment but also in cultivating interpersonal and self-management skills for overall performance enhancement.

FFE's Mentoring Program 2022-23 garnered an enthusiastic response from both Mentors and Mentees. This year, professionals from over 85 corporate entities, FFE alumni, and individual volunteers offered guidance to a total of 1241 FFE scholars in Engineering, Law and Pharmacy. On an average, mentors dedicated approximately 24 hours over the span of 4-6 months ensuring our graduates are well-prepared for their career ahead.

To capture the program's impact, FFE collected feedback forms from mentors and mentees upon completion. The feedback was incorporated into the 'Annual Impact Report 22–23', shared with all corporate partners. Participants expressed high satisfaction levels with the mentoring program (both mentors and mentees) with over 90% affirming that the modules and topics were pertinent, practical and immensely beneficial for FFE scholars.

To express gratitude to our corporate partners and their employee volunteers for completing another successful year in FFE's mentorship program, FFE conducted 10 'Mentorship Closure Sessions' in 22-23 cycle. While the sessions for Tesco Bengaluru, o9 Solutions and Mu Sigma were held at their respective offices in Bengaluru, virtual closure sessions were held for Fractal Analytics, Dell Technologies, TransUnion CIBIL, Thomson Reuters India, Microsoft, Firstsource and Alvarez & Marsal. FFE took this opportunity to thank all the employee volunteers for their participation, felicitated the 'Star' and 'Outstanding' mentors with certificates, showcased the program's impact and heard feedback from mentors and mentees.

FFE'S VIRTUAL OPEN HOUSE SERIES

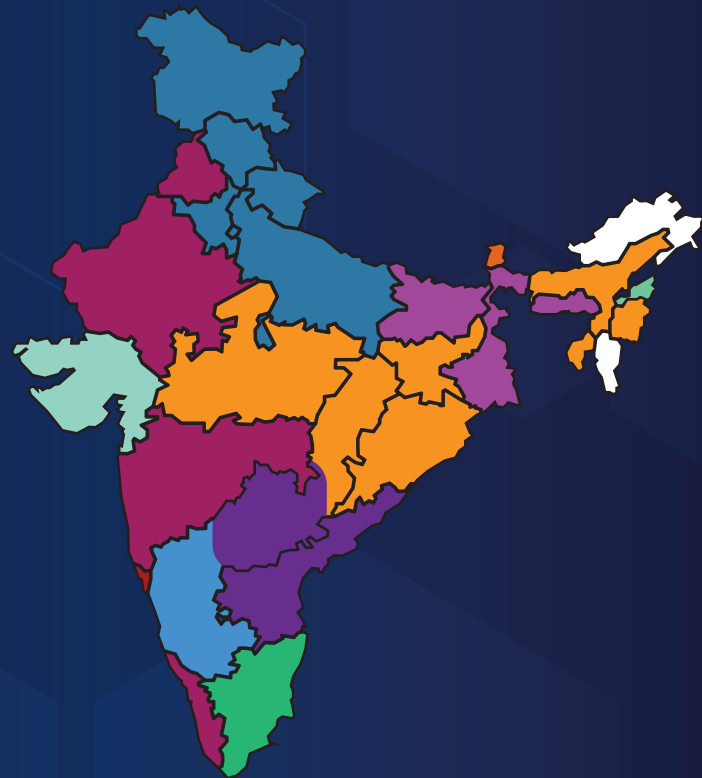
FFE hosted 9 Virtual Open House events during FY 2022-23, covering 27 states in India with close to 7500 participants attending the events virtually.

Through these well organised interactions, meticulously planned, facilitated and supported by FFE, over 900 scholars had the opportunity to interact with their donors at events spread across the entire year.

It was truly heartening to also witness some donor organizations choosing to organize in-person meetings. The physical gatherings, not only enriched the interactions for FFE scholars and made it an invigorating experience but also added a new dimension to their engagements.



ALUMNI PROGRAM



The alumni of FFE represent the Foundation's future and its trajectory. Their ongoing financial contributions, along with their active engagement as Facilitators and mentors, play a pivotal role in the success of FFE's Pay Forward model, embodied in the Circle of Giving. In this model, students pledge to provide assistance and support to at least two fellow students, mirroring their own journey.

FFE alumni donated Rs 2,03,63,636 to FFE India Trust during FY 2022-23; alumni mobilized additional donations of Rs. 1,68,31,825 through CSR funds from the corporates that employ them and from their professional and personal networks. The corporate matching grant of Rs. 6,20,224 donated to FFE India Trust- included the donation and efforts of over 20 FFE alumni from VMware, Paypal, Microsoft, Google, Juniper Networks, Adobe, Oracle, Ciena, LinkedIn and Synopsys.

The partnership between Cognizant Foundation and FFE India Trust continued into the third

consecutive year, wherein Cognizant Foundation matched FFE alumni contributions to support 190 scholars. During FY 2022-23, FFE India Trust received a grant of Rs. 38,00,000 from Cognizant-Foundation that was matched by an equal amount in FFE alumni contributions. A total of 706 Alumni donated towards this matching grant.

Total contributions by FFE alumni (direct and indirect) to FFE India Trust amounted to Rs. 3,71,95,461 during FY 2022-23 by 1528 alumni donors, directly supporting scholarships. This includes 416 first time alumni donors and 1112 repeat alumni donors. Apart from donations received in India, 21 alumni have contributed \$16,734 to FFE US.

Alumni contributions to FFE India Trust during FY 2022-23 alone helped support close to 8% of the total scholarships granted (994). The total cumulative alumni contributions to the Trust from its inception in 2003 until 31st Mar 2023 is Rs. 9,72,07,061.95.

"I was born into a modest lower middle-class family in the quaint village of Narasinga Puram, located in the Attur Taluk of Salem district in Tamil Nadu. Among my family members were four elder sisters. My parents, who were dedicated farmers, managed to support my education up to the 10th grade. At that point, their financial means became insufficient to continue funding my studies. Despite this, I achieved an impressive 93.75% in my 10th grade exams.

For the 11th and 12th grades, Sri Saradha School, Attur authorities waived my fees, urging me to excel academically. During my 12th grade, the realization dawned upon me that pursuing higher education at a college would demand significant financial resources, unless I managed to secure a spot at one of Tamil Nadu's top universities.

As fate would have it, I attained a remarkable score of 198.5 out of 200, with exceptional marks in physics (196), chemistry (200), and mathematics (199). This accomplishment granted me the opportunity to enroll in the prestigious Madras Institute of Technology (MIT) in Chennai, an Institution renowned for being the alma mater of Dr. APJ Abdul Kalam during his pursuit of a master's degree.

Though I had gained admission into this esteemed institution, concerns about my family's financial predicament plagued my mind. The four-year engineering program necessitated a substantial sum of Rs. 2 lakh. Seeking financial assistance, I approached the college administration, which led me to the guidance of Mr. Vasudhevan and Mrs. Mala Vasudevan, dedicated FFE facilitators. After assessing my background, they recommended me to the Foundation for Excellence (FFE), which resulted in my annual scholarship award from 2010 to 2014.

Tragedy struck with the loss of my father in 2011, further deteriorating our financial circumstances. FFE's unwavering support allowed me to continue my education. For a young man coping with the loss of his father, the FFE scholarship served as an enormous source of support. It's accurate to state that FFE played a crucial role in shaping the course of my life for the better.

Throughout my college tenure, I was able to stay focused on my studies while also engaging in activities like the Rotaract club, dedicated to enhancing the lives of orphaned and differently-abled children. I wish to give something back soon to the community both as a doctor and as a donor to future students like me, to help them achieve their goals."

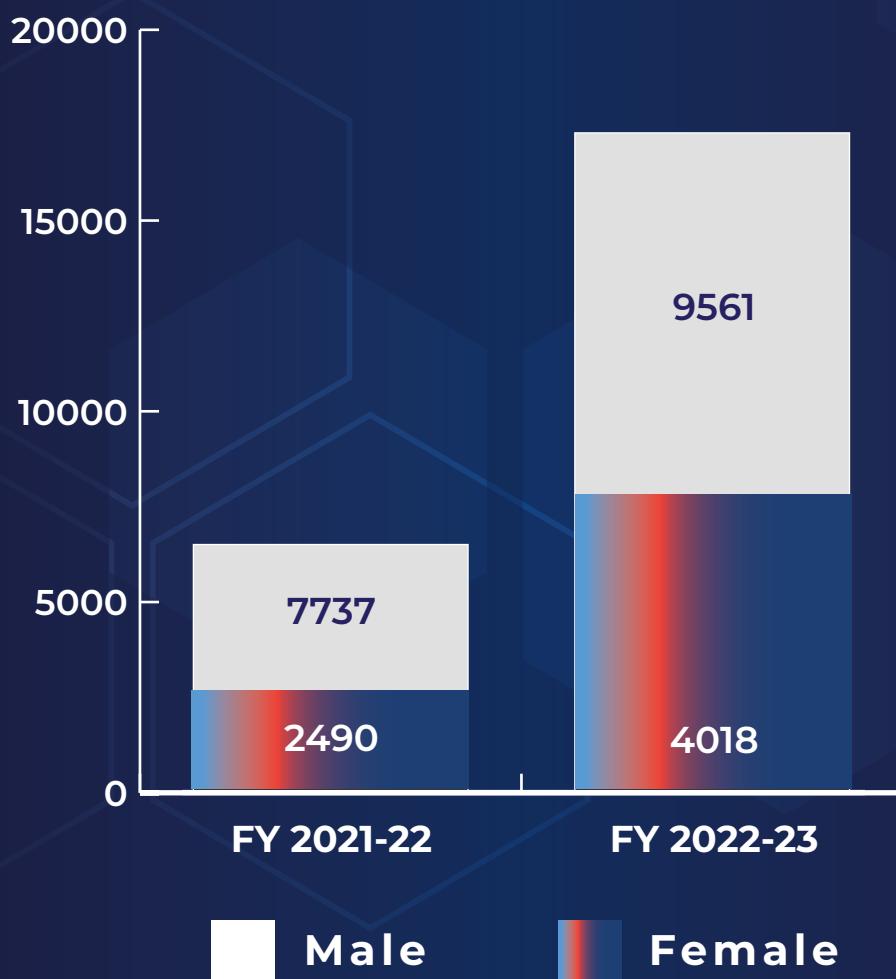

COMPARISON BETWEEN FY 2021-22 & FY 2022-23

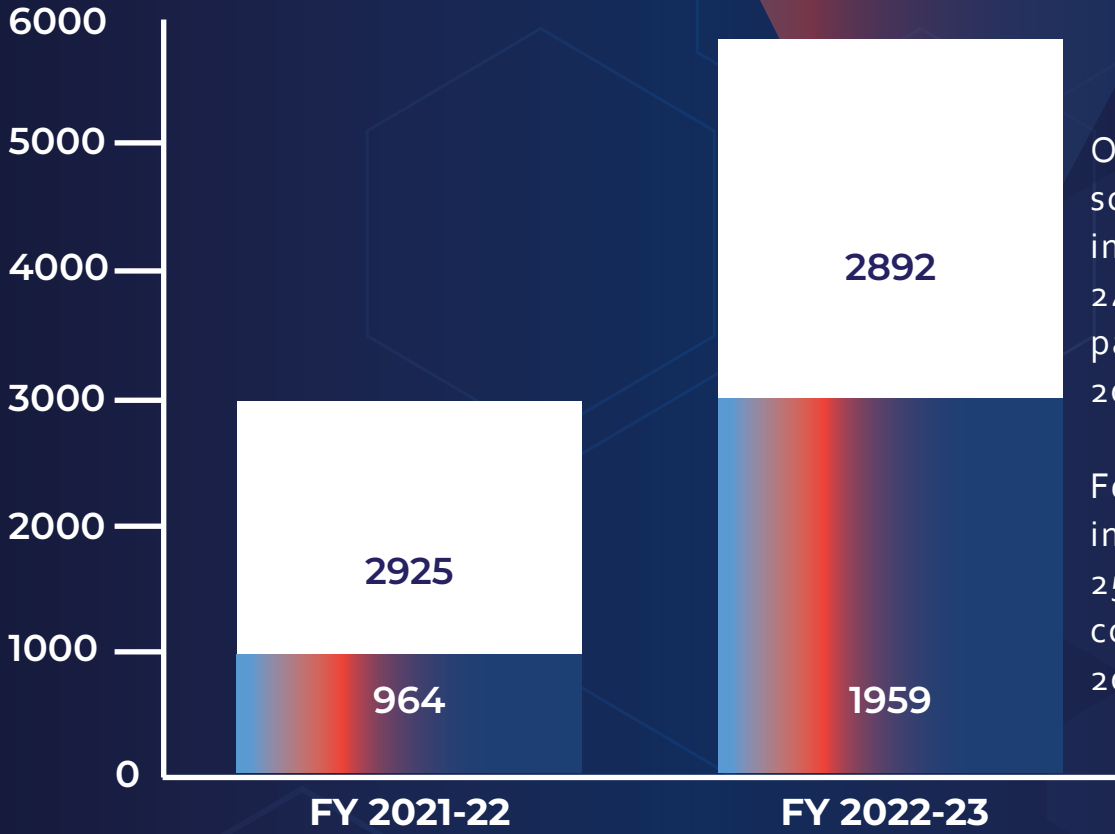
OVERALL STUDENT COHORT

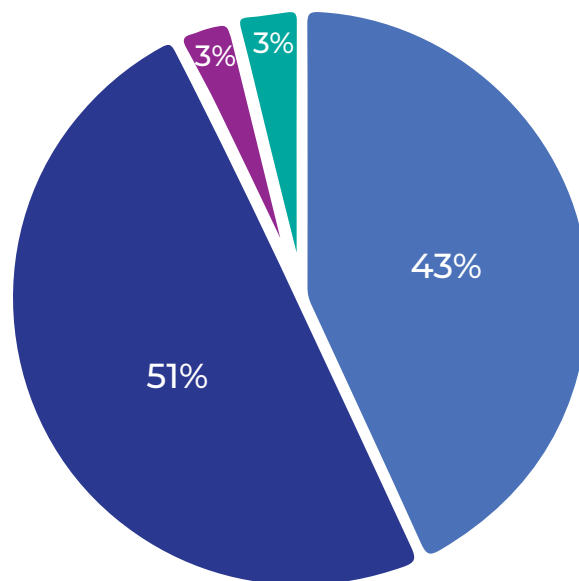

- 1) FFE INDIA TRUST is registered under Foreign Contribution (Regulation) Act, 1976 vide Registration Number 094421348.
- 2) The Trust has a FCRA Bank Account at State Bank of India, New Delhi Main Branch, FCRA Cell, 1st Floor, #11, Sansad Marg, New Delhi – 110001 and all the foreign remittances are credited to this account.
- 3) During the financial year ended 31st March 2023, the Trust received Foreign Donations of Rs. 21,57,98,995.44 comprising of remittances from Foundation for Excellence Inc. USA amounting to Rs. 15,54,79,132.00 and Rs. 6,03,19,863.44 from other Donors. The Trust has also received Rupee Donations amounting to Rs. 43,10,82,545.40 into the Non-FCRA Account.
- 4) During the Financial Year ended 31st March 2023, the total amount disbursed as Scholarships was Rs. 59,63,24,312.00 comprising of Rs. 19,21,07,760.00 from the FCRA Account and Rs. 40,42,16,552.00 from the Non-FCRA account.
- 5) Depreciation is calculated as per rates prescribed by Income-Tax Rules.
- 6) It is the policy of the Assessee to prepare its Financial Statements on cash receipts and disbursements basis. On this basis, revenue and related assets are recognized when received rather than when earned and expenses are recognized when paid rather than when the obligation is incurred.
- 7) The Fixed Assets are disclosed at actual cost less depreciation.
- 8) Since the Assessee follows the Cash System of accounting, revenue is recognized on receipt of income.
